	(iv)	To advise on, and implement appropriate measures for, the provision of such information, instructions, training and supervision as is necessary to ensure the health and safety at work of employees.	
	(v)	To be responsible for the formulation and implementation of social and recreational activities for the benefit of the Authority's employees;	

	(vi)	To perform other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according their postings.
